I attest that the equipment described above is sea worthy and is in active use, that all information I have supplied is accurate and truthful, and that I accept the terms of this AGREEMENT. I further agree that placement of any vessel on the rack will be assigned to me and **I agree to remove my boat from the rack prior to December 1st** and to immediately comply with any notification I receive from the Village to remove my vessel for any reason the Village deems necessary. I also agree to pay any fines associated with the use of the Boat Rack that is not in compliance with any of the provisions contained in Chapters 43, 99, 132, 161, 162 and 173 of the VILLAGE OF POQUOTT Code.
